Reports for Parish Council meeting 6th June 2024

Clerks Report

1. The Clerk has contacted BMBC asking for No Dog Fouling stencils to be installed in The Park (street name) not the park, Cannon Hall Park
2. A resident of Church Lane complained about a large pot hole on Church Lane. The Clerk reported this to BMBC who replied that it is an unadopted road and therefore not their responsibility. The Clerk then contacted Yorkshire Water as the pothole is adjacent to a manhole. YW will inspect and reply.

3. The Clerk reported to highways that Cawthorne Lane from Clay Hall to Kexborough bridge has many potholes and that the road is eroding at the edges. Reply that any actionable defects will be picked up as part of the monthly inspections.
