Cllr Broadhead: (i) two plum trees in the Orchard have been damaged (ii) dog fouling in the village (iii) people are parking on the double yellow lines and could traffic enforcement be asked to visit (iv) she and Cllr Eyre attended the YLCA Sth Yorks. Branch meeting, guest speaker the Sth Yorks. Police and Crime Commissioner Dr Billings.

Cllr Eyre: (i) people are parking on Tivy Close at school time on both sides of the road making it difficult for traffic (ii) North Lane Speeding Group meeting, parish councillors have been invited to attend.

Cllr Ellis: He has arranged for collection of the Parish Council's Christmas tree.
