**Cllr Kilner:** the road surface on Darton Road from Low Mill Farm to Clay Hall is disintegrating at the sides and has potholes.

**Cllr McNally:** there may be some funding available for the Jubilee Wood

**Cllr Walker:** (i) the school will arrange for the branches obscuring the street lights on Tivydale Close to be removed (ii) there is a skip on Darton Road opposite the junction of Five Acres which needs to be removed.

**Cllr Ellis:** the boundary hedge of the school needs trimming back (*Cllr Walker to contact the school*)
