Minute No 102 ACCEPTANCE OF THE MINUTES OF THE PREVIOUS MEETING

It was noted that the minutes did not include that the barriers at Cannon Hall car park were stuck and needed reporting and also that a name had been used in the minutes for the gifted land. In minute 87 where it was discussed that there would be a review around the Orchard Play area it was noted that the review was to be around a fence being erected if the signs had not had the desired effect.

Minute No 103 GIFTED LAND WOODLAND

Cllr Eyre lead on this discussion where he talked about a meeting that was had at the gifted land off Dark Lane This meeting was attended by Cllr Stephen Eyre, Cllr David Barron, Cllr Steven Rusby, Cllr Sara Shaw, Cllr Jane Wilson, Cllr John Walker, Clerk to the Parish Council A Winstanley and also A Bramall Cawthorne Primary School. The discussion concluded that there would be too many ongoing costs involved with taking on this land and the fact that it would be using public money was of concern. A vote was had on whether to accept the land and resulted in 7 votes against, 1 in favour and 1 abstained. It was decided that a letter would be sent thanking the resident that was gifting the land for their kind offer but declining due to ongoing costs etc, it was also decided to send a letter to ex Cllr Peter Kilner for his help with the matter previously.

Minute No 104 CEMETERY WORK UPDATE

It was discussed that there is a lot of work to be done within the cemetery. There are a number of trees that need to be inspected and a lot of general pruning and cleaning up etc. Cllr Barron explained that Richard Thewliss will be attending to do a walk around the cemetery and provide quotes and advice of what will be needed. Jason will help with the general handy man maintenance and provide quotes also where he is needed. It was also discussed that planning permission may be needed once we know what needs doing with trees etc – also it was decided to e mail conservation once we knew exactly what was needed.

1. The clerk attended a meeting with the cemetery committee on 18th September where it was established that there was some work to be done with regards to the tidying up of the cemetery – A meeting to be had with Richard Thewliss and Jason to determine quotes and a list of jobs

Minute No 110 TO RECEIVE MEMBERS REPORTS

Cllr James McNally mentioned there was a overhanging tree on Darton Road , it was established that BMBC already knows about this and will be dealing with it as soon as possible.

Cllr Eyre mentioned overgrown vegetation on Lane Head Road was encroaching onto pavement. A letter is to be sent from Clerk on behalf of Parish Council to all residents involved. Cllr Eyre also mentioned the grass verge was also encroaching, Cllr Robert Barnard commented that he would have a look in daylight and have a word with the Highways department.

Cllr Eyre brought up that at the last meeting Cllr Barron had mentioned that the village needed some revitalising and that he had been having a look round and had also noted that there were weeds etc that needed cleaning up and general maintenance needed. It was suggested that a working party be got together. Cllr Barnard asked if there were any photos he could pass on.

Cllr Wilson reported that the street light that had been brought down by the fallen tree at the cemetery had now been replaced

Cllr Rusby mentioned that at the side of the bus shelter there was a coping stone that had been drilled into and green fencing erected . This was apparently only to be a temporary measure , however the fencing is still there and is unsightly – a letter is to be written to resident to ask when it will be replaced. It was also mentioned about the two bungalows on Church Street that the front gardens were in some need of a clean up. Cllr Rusby also

asked if the museum wall had been tended to as per flooding when raining. Cllr Eyre said he would chase up.

Cllr Walker mentioned that the potholes on five acres saying that still nothing had been done and also that the signs for 30mph at the bottom of five acres were ignored. Cllr Barnard said he would have a look at schedule to see when the potholes were going to be looked at.

Cllr Barron raised a comment about a notice board being erected in the cemetery with rules and regulations on it as it was noticed that there are items being placed in the cemetery that should not be there – it was also asked that his be put in the Parish Magazine.

Cllr Broadhead raised the subject of Remembrance Sunday which will be on the 10th November and said the Peter Kilner had been asked to carry the flag. More arrangements would be discussed and finalised at the next Parish Council meeting
