Cllr Shaw reported that there had been a company putting in fibre on St Julians Mount that had left a real mess – Cllr Shaw was going to find out who the company was and then the clerk could write a letter or ring to report.

Cllr Wilson talked about the footpath from top road down to Stanhope Avenue being overgrown– Clerk would get in touch with Public Rights of Way. Also two houses on St Julians Way with overgrown hedges – Clerk will post a letter.

Cllr Broadhead mentioned the iron bridge area being littered with dog fouling – the clerk will mention this for the Parish Magazine.

Cllr Jackson mentioned a hanging basket with no sign – Clerk would look on list to see if there should be a sign. Also a fence that is flattened on the Cannon Hall Estate – The clerk will look into this.

Cllr Walker mentioned the bench that needs to be put in the cemetery as he keeps getting asked about it by a resident of the village and also the No Dogs Allowed signs for the Orchard.
