Cllr Wilson – Tivydale near the school there had been a bollard knocked down and this needs mending – Cllr Walker was going to ask in school regarding the bollard. The bins on Church Street from Maltkin Row were once again being left out – The clerk will send another letter to the properties concerned.

A holly bush on Tivydale close needs tending to by the owners – the Clerk will put a letter through.

There has been some digging at a property near the cemetery, this is to change the access to the property and replace the boundary fence. The digging has left large gaps and could be dangerous if people get their foot caught in them. The Clerk will put a letter through if needed.

The recurring problem of dog mess all over – the Clerk was asked to put this in the parish magazine and on Cawthorne News.

Cllr Broadhead asked the Clerk to find out if permission was needed to put solar panels on a roof – The Clerk will ring Norcroft Energy and ask the question.

Cllr Jackson asked that the football club be reminded not to wipe and clean their boots on the pavement as it caused a real mess – Clerk will make contact with football club.
