Description: Demolition of dwellinghouse and associated outbuildings and erection of 1 no.

dwellinghouse

Location: 2 Hill Top, Cawthorne S75 4HG

Six of the seven members of the public spoke.

They all gave their objection to the demolition of the existing house on the grounds of it being a historic building within the conservation area.

They all gave their objections to the design of the proposed house on the grounds of it being an unsuitable design in a conservation area.

The Planning Committee of Cawthorne Parish Council object strongly to the demolition of the existing dwelling on the grounds of it being of historic value to the village; parts of the house date to 1711.

The Planning Committee of Cawthorne Parish Council also object to the proposed design of the dwellinghouse. It contravenes BMBC Core Strategy Policies 29 Design Principles and 30 The Historic Environment. It contravenes the Village Design statement as it would infill the gap which provides views out of the village. The roofline is higher than the existing and the building will dominate the street scene. It is a totally unsuitable design for that location.
